## CHAIRMANS REPORT 2022 2023 Financial Year

**FINANCIALS,**I am very pleased to be able to report that we have had another successful year, with the recent receipt of our Audited Accounts for the year 22/23 Indicating a trading profit \$95,332.00. In addition, Our Club Grants commitment was in the order of \$40,000. I consider this to be a very acceptable result, given that we have achieved this result having funded improvements both in our Gaming area and our Outdoor areas, within the approved budget.
